1. Apologies.

2. Declarations of interest.

Cllr Jeffery declared an interest in Church Cottages and Highways. Cllr Dodd declared an interest in Highways

3. Approval of previous minutes and Matters Arising

5. Correspondence

- a. DNPA -Annual Parking Pass Survey- Clerk to reply saying that it will only encourage people to park on the verges. How will it be enforced, do they have authority to fine, are they going to have more staff or will they be taking staff away from their already large workload?
- b. Seat- Cllr Pearce (WDBC) stated that the seat at Church Lane has been removed for repair. The money for the oak is to come from the Localities Budget and Cllr Pearce has granted us £110 for the job. It was noted that the seat repair has taken longer than expected.
- c. Cllr Philip Sanders is unable to come to a meeting on the second Wednesday of the month as he already has a standing engagement. Next Meeting try to make a meeting that will be able to be attended by Cllr Lane and Cllr Pearce.

6. Clerk's Courses

Clerk asked for permission to attend 'Understanding VAT' and 'Preparing for Audit for Larger Authority'. Both courses agreed.

7. Church Cottages

Two quotes were obtained to survey the properties. Both quotes were for £500 plus VAT. The quotes were from Vickery Holman and Braithwaite Associates. After discussion it was

agreed to go for Vickery Holman as they had already prepared a report in previous years. Proposed Cllr Jeffery Seconded Cllr Skillicorn – all in favour. Clerk to arrange for the survey. The shed at no 1 will be delivered in approx. 4 weeks. It would cost £200 for a new base so it was decided that the council would prepare the base themselves, Cllr Skillicorn to find out how the base needs to be set up. The roof will be galvanised with a waterproof membrane underneath to stop any drips.

Cllr Jeffrey stated that the septic tank had been emptied.
