4. Reports from Outside Bodies

There was a meeting held between Western Power, Duchy of Cornwall, Dartmoor National Park Ecologist and Peter Tavy Commoners Chairman and Secretary and Parish Council Chairman, at the Coombe on 21 February. Western Power were shocked at the state that was left after the works and say that they will work with their own ecologist and Duchy to put things right. They liked the idea of a track remaining for access but there was some concern about local wildlife, that is the voles, being affected.

WP are thinking about re-routing the electricity lines.

WP, Ecologists, DNPA and Commoners all to agree the action to be taken.

The Southern Links meeting has been postponed until 2 April 2020. Cllr Lane asked permission for him to write to the Southern Links Clerk to ask what progress has been made regarding when there will be a visit to the parish regarding the highways. Permission was given.

Coronavirus- Clerk to check the emails sent from West Devon and disseminate the information on Facebook, website and Notice Board. It was thought that a list of the over 70's and any other vulnerable people should be kept and help given when required.

5. Correspondence

There was a quote for the replacement of the basin in no 1 Church Cottages. The floor beneath the basin will need to be investigated at the same time as there is a recurring pool of water and the floor has a definite slope.

The SWWA drain cover at the corner of Langsford Road has now become dangerously sharp. Cllr Pearce will action this.

Water comes across Village Way and causes problems when there is ice. Cllr Jeffery stated that what was needed was a pipe from the garages at Barbetha and Wier Cottage under the road. Cllr Pearce will action.

It is noted that there are potholes on the road through Cudlipptown to Baggator and Wapsworthy
